THE FOUNDATION:

The Legal Research Center was established in the Ministry of Justice in the Kurdistan Region of Iraq, based on an initiative by His Excellency the Minister of Justice, Mr. Farsit Ahmed Abdullah, and the founding was approved by the Presidency of the Council of Ministers on the date of 2/11/2020, and the founding statement was issued on 24/11/2020, and it was published in the Kurdistan Official Gazette in the number 260. on 24/12/2020. The Center received great support from the President of the Cabinet Office in the Region, Professor Dr. Umaid Sabah Othman. and it was chosen Professor Dr. Mohammed Sulaiman Al-Ahmed. Professor of Civil Law at the College of Law in the University of Sulaymaniyah, as a chairman and director of the Center. With full support from the Kurdistan Region of Iraq, since November 2020, the Center embarked upon a rigorous campaign and raced against time to produce its scientific and cultural products.









THE CENTER MESSAGE:



On the path that a cultural radiance and an effective contribution that have a mark in developing the global legal culture, establishing bridges of knowledge communication, and supporting all forms of exchanging the legal ideas and information aboard, the Center has been keen to publish most of its researches, studies and books in both Arabic and English languages, to deliver the messages of peace and legal harmony worldwide.

THE GOALS:

Enhancing the legal culture and improving its understanding.

- Opening up the global culture and enhancing the knowledge and teaching of it.
- Publishing those topics that have global and regional legal impact.
- Redefining the current legal culture in the Kurdistan Region and supporting its development in a way that serves humanity.
- Providing the educational, academic bodies and publishers that specialized in law with the Center's publications in a way that enhances the achievement of the Center message.
- Facilitating the access to the most prominent global developments in the field of legal research, legal provisions and judicial decisions.
- Encouraging the preparation of comparative legal studies and advancing the wheel toward the comparative law.



THE MECHANISM:

To deliver its message and goals, the Center relied on several mechanisms and tools, which formed the platforms and established the channels through which the Center could convey its message worldwide:

Issuing Journal: The Center issued the Social Contract journal, as the first international peer-reviewed, free scientific journal that does not charge any fees from scholars and researchers. twelve issues of journal were published during the last four years.

Holding Conferences: The Center held five international scientific conferences, with significant international participation, during the last four years.

Holding Round Tables (discussion): the Center invited jurists and experts to meet and discuss a specific legal topic. During the last four years, the Center held four round tables. Publishing Books: The Center has published (25) books in various legal fields.

Publishing Booklets: The Center has published (21) booklets in various specializations for senior jurists and researchers in the field of law.

Publishing Translations: The Center began selecting important topics to translate, and began issuing two books within the translation platform.

Meetings and Visits: The Center had a remarkable presence in several conferences, seminars, meetings and lectures inside and outside the Kurdistan Region, Iraq and abroad.








SOCIAL CONTRACT JOURNAL (SCJ):

This journal is an international peer-reviewed scientific journal concerns with publishing legal studies, after subjecting them to scientific and academic review. This journal is the first academic journal in Iraq that does not charge the researchers and scholars any fees. The Center published (8) serial issues of the journal, and (4) special issues in which the proceedings of conferences and round tables that have been prepared by the Center.

The journal is focused on publishing scientific and academic research, articles with significant legal substance, commentary on judicial rulings and decisions, abstract of approved university theses and dissertations, and book review for those books with a prestigious scientific level and academic reputation. The language of publication is Arabic, Kurdish and English. From various backgrounds inside and outside Iraq, the journal has published approximately (125) research papers and legal studies in various legal specializations and branches.
