1. The **Government of the Republic of Iraq** has received a loan from Japan International Cooperation Agency (JICA) towards the cost of **“Sewerage Construction Project in Kurdistan Region (IQ-P23)”**. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for **“Sewerage Construction Project in Kurdistan Region (I): LOT-1”**.
2. **General Directorate of Water and Sewerage of Ministry of Municipality and Tourism Kurdistan Regional Government – Iraq** (“the Employer”) now invites sealed Bids from eligible Bidders for the construction and completion, and two-year operation and maintenance service of **“Sewerage Construction Project in Kurdistan Region (I): LOT-1”** (“the Works and O&M Service”) making part of the “Sewerage Construction Project in Kurdistan Region (I)”.
3. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Bidders from eligible source countries, as defined in Section V of the Bidding Documents.
4. Interested eligible Bidders may obtain further information from and inspect the Bidding Documents at the address given below from **0900 hours to 1400 hours (Erbil Local time) Sunday to Thursday**. Details of eligible Bidders are explained in “Operational Rules of Special Terms for Economic Partnership (STEP) of Japanese ODA Loans 9th May 2013”. In addition, the instance which is listed in “Specially Designated Nationals List (SDN)”, subject of any similar sanction, possibly face such sanction, and/or impede Bank transfer for payments under the project shall not be eligible.
5. A complete set of Bidding Documents may be purchased by interested Bidders on the submission of a written application to the address given below accompanied with duly signed and stamped (1) Confidentiality Declaration, (2) Confirmation of being eligible Bidders in accordance with “Operational Rules of Special Terms for Economic Partnership (STEP) of Japanese ODA Loans 9th May 2013” and payment of a non-refundable fee of USD 500 (Five Hundred US Dollars) to the bank account listed hereunder:

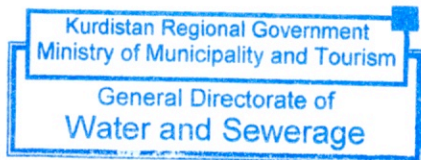

8. Bids will be opened in the presence of Bidders' representatives who choose to attend at **1130 hour (Erbil Local Time) on Sunday, 26 January 2025** at the address given below.
9. Notice to the foreign bidder: The Contractor who are going to work in Kurdistan Region should have the official registration of its office in Kurdistan. It is a legal requirement to perform his duties and activities as the Contractor. In addition, the Bank Guarantees for the Contract are requested to be authenticated by the Central Bank of Iraq.
